During the holidays

Bridging week (six separate childcare days)

The bridging week consists of six separate care days. These can be selected as required. This means that they can be taken on individual days off, such as bridging days. These care days can also be taken individually before or after a holiday week or divided up as preferred.

Holiday weeks (for the whole coming school year)

The childcare in a holiday week always comprises a period of seven days in the holiday period. A weekend or any public holidays that fall within these seven days count as part of this care week. The holiday week can start at any time within a calendar week - and it always finishes at the end of the seventh day. Holiday weeks can be taken individually or connected together. Up to **eleven holiday weeks** can be booked.

The level of the attendance fee to be paid and the contribution towards the costs of the mid-day meal depend on the size of the family, earning capacity and the number of younger siblings in fee-based care.

Note:

I am/We are aware that all-day childcare provision can only come about through a binding contract of care with the cooperation partner.

Any bookings for childcare services always apply for one school year. In exceptional cases during the current school year, the booking of your care services can be changed in the course of one calendar quarter to come into effect in the quarter after next. In principle this excludes the time from 13.00 to 16.00. Any changes in all-day care in the shorter term must be agreed by the school's cooperation partners. After the school year has already begun, however, any change can only take place at the beginning of the next month at the very earliest.

I am/We are aware that any false statements of income and family circumstances could constitute the offence of criminal fraud and may lead to additional fees being claimed retrospectively. I am/We are aware that my/our details may be subject to verification at any time.

If the income stated above changes by more than 15 % in the course of the school year or a younger sibling is enrolled in, or taken out of, fee-paying childcare, you may apply for a re-calculation of the fees.

This information is purely for the organisation and realisation of the childcare programme and the provision of midday meals, including calculation of the charges necessary for this. They are a condition for granting the legal benefits associated with this. The processing of which is based on sections 98 (1) and 13 of the Hamburg Education Act combined with section 1 of the Hamburg Schools Data Protection Regulations. The name and address along with the desired care times (but excluding any details about financial circumstances) are forwarded to the provider who carries out the childcare service. The operator of the school canteen receives a communication about the level of subsidisation of the food allowance as appropriate. The school office provides information about the stored data. All requests to revise any data are also accepted there.
