WHAT IS FEMALE GENITAL MUTILATION?

Female genital mutilation (FGM) is the complete or partial removal of the external female genitalia by cutting for non-medical reasons.

It is a violation of a person's human rights.

FEMALE GENITAL MUTILATION IS EXTREMELY HEALTH-DAMAGING

FGM often causes serious lifelong health problems. Through this practice girls die from blood loss or an infection. Many women suffer life-long pain and lasting physical and psychological problems, for example:

pain during urination as well as during sexual intercourse, incontinence, severe menstrual problems as well as bladder and uterus infections.

Further consequences can entail:
infertility, problems during childbirth or severe depressions.

FEMALE GENITAL MUTILATION VIOLATES INTERNATIONAL AND GERMAN LAW

FGM is punishable in Germany. Whoever mutilates or attempts to mutilate the external genitalia of any female person faces a prison sentence of maximum 15 years. This also applies when the crime was committed abroad.

Parents who subject their daughter to genital mutilation or arrange for this to be carried out by someone else in Germany or in a foreign country will likewise be liable to prosecution.

If FGM has been carried out or attempted to be carried out, the daughter may be located in a secure shelter by public service for short or long term and parents might lose custody of the child.

Parents who are sentenced for carrying out FGM and do not hold German citizenship may in addition lose their right to temporarily or permanently live in Germany.

Girls should be able to grow up sheltered and protected from any abuse and injury to their physical integrity. It is the government's responsibility to ensure that violations of such children's and women's rights don't go unpunished.
